- All performers must be enrolled or employed by Seminole County Public Schools. Family members may perform along with a student or employee.
- Auditions will be held:
 - **Tuesday, October 20 at Seminole High School, 2701 Ridgewood Avenue in Sanford**
 - **Wednesday, October 21 at Lyman High School, 865 S. Ronald Reagan Blvd. in Longwood.**
- Auditions times will be scheduled in 30-minute windows starting from 2:00 p.m. - 8:00 p.m. Plan to arrive at least 30 minutes prior to your scheduled audition time block. When you arrive, check in with The Foundation staff in the auditorium lobby and you will be issued an audition number.
- **Dance and Vocal Performers:** If you require recorded music to perform your talent, you **must bring a CD** for the audition and leave it with **The Foundation** staff member at registration. **IT WILL NOT BE RETURNED.** The CD must be compatible with standard audio equipment. No tapes.
- Background music can be purchased at websites such as www.musicminusone.com and www.pocketsongs.com.
- If you plan on using live accompaniment the night of the event, you **must** audition in that manner.

- If performing as a group - an application form and a **Photograph, Motion Picture & Video Consent: Waiver and Release Form** must be completed for each group member. **Group applications must be submitted together.**
- All performances are to be a **MAXIMUM of THREE minutes in length**. You will be asked to stop if you go over the time limit.
- Piano, microphones (standing), chairs, sound system, music stands and a CD player will be provided. **Performers must provide all other equipment!** You must audition with the equipment that will be used at the performance.
- Restrooms will be available for changing.
- No cameras, videos or recording devices will be allowed. Parents will be permitted to sit in the rear of the auditorium during **their child's audition**.
- You will be notified **via e-mail** no later than **October 13, 2015** of your scheduled audition time. We cannot guarantee a particular day or time for auditions. Please call 407-320-0196 if you have any questions or are unable to attend your scheduled audition time. **Note: As all audition times have been assigned, please try and make your scheduled time. We cannot guarantee another date and time.**
- A ***Photograph, Motion Picture and Video Consent Form*** must be signed by each performer and parent/guardian and returned with a completed application.
- Those who are chosen will perform in the ballroom at The Westin Lake Mary on **Saturday, November 21** and **must** be available for the afternoon/evening dress rehearsal on **Friday, November 20**.
- **Note: A limited number of acts will be selected by the audition judges for performance.**
