2022 was a record year for The Foundation for Seminole County Public schools. Thanks to your partnership, we reached new milestones across the board. While our mission remains the same, our impact continues to grow.

This year that impact included over \$1.2 million in grants to district priorities, a 16% increase in the number of college scholarships awarded, and the rollout of a new professional development series where 100% of the attendees thought it was an effective program. In addition, we upped our support of the Families in Need Program to provide resources for homeless and low-income students, distributed school supplies to classrooms in need, and rebranded the annual fundraising gala to A Night of Impact. THE IMPACT OF **SCHOLARSHIP**

The Foundation had a record scholarship year with over \$64,000 in college scholarships awarded to 43 high school seniors! These scholarships are privately funded by individuals and the business community and are designed for students

planning to attend state colleges, universities, or vocational-technical programs throughout the country.

New this scholarship season:

- Foundation Impact Scholarships available to one student with financial need at each of the 10 high schools.
- Several career-related scholarships for programs such as nursing, trade programs, engineering, and the arts.
- Dr. Walt Griffin Scholarship Fund.

TAKE STOCK IN CHILDREN

Take Stock in Children offers deserving, low-income students a chance to escape the cycle of poverty through education. The program provides 103

hard-working students with the tools to thrive throughout high school, into college, and in their future communities with college coaching and student workshops. Our program begins the summer after 8th grade and includes wraparound services such as weekly mentor sessions, workshops, support by Foundation staff, and the promise of a two-year Florida Prepaid Foundation Scholarship upon graduation.

One of the key success factors of the program is the mentoring, which leaves a lasting impact on both the student and mentor.

TOOLS 4 SEMINOLE SCHOOLS

Teachers often spend \$500 or more of their own money buying supplies for



their students and materials for their classrooms. Tools 4 Seminole Schools collects and distributes school supplies and classroom materials to teachers, who in turn ensure their students have what they need to be prepared for class. In 2022, teachers shopped at the store nearly 2,400 times and received on average, supplies valued at \$519 each time they shopped.

The store has everything from pencils, notebooks, and crayons to tissues, socks and underwear, providing whatever is needed for students to be in school, ready to learn. With about half of Seminole County's students qualifying for free or reduced meals, the need for this type of support is undisputed.

The store is funded through The Foundation and primarily supported by grants, corporate giving, individual donors, and our annual supply drive every summer. Over 150 businesses, civic organizations, and individuals come together each year to collect thousands of school supplies to keep the shelves stocked all year long.

GRANTS FOR GREAT IDEAS



Each year, teachers have the opportunity to put their great ideas into action for their students through the Foundation's Grants for Great Ideas program. Teachers are eligible to apply for up to \$750 for an individual classroom project and up to \$2,000 for a grade or school wide initiative in three categories: English Language Arts, STEM, or Arts. Since 1989, the Foundation has awarded over \$1.83 million to support hands-on projects for students.

These projects go beyond normal classroom instruction and allow teachers to provide memorable experiences for their students. Over \$62,000 given out in grants in 2021-2022 helped 10,500 students receive positive learning experiences through this program.

These hands-on projects help students observe, question, learn, and most of all, achieve!





MAKING AN IMPACT

FOR OUR SCPS TEACHERS & STAFF



Each day, students go to school and are supported by not only teachers, but a variety of support staff. Bus drivers ensure students make it to school safe, dining staff serves healthy meals, and front office staff greet each student with a smile. The Foundation recognizes the importance of developing the teachers and staff that work with our children.

Each year, the Foundation recognizes over 135 exceptional teachers and employees through Teacher and Employee of the Year Celebrations. Staff are invited to attend with their principals and families and receive award checks and recognition for their service.



Last year, the Foundation launched the Educational Leadership Academy. This is a professional development series offered to Teachers of the Year. Thirty-one teachers attended sessions to help them create a positive, inclusive classroom culture. The professional learning sessions were held afterschool and teacher leaders from across Seminole County focused on building relationships with students, understanding bias. and working with students from diverse backgrounds.


By providing teachers with the necessary knowledge and skills needed to establish a positive inclusive school culture and addressing educational inequities, the Educational Leadership Academy is expected to increase retention of highly effective teacher leaders. As a result of the series, 100% of the teachers agreed that the knowledge learned will help them at work, and since participating in the series they have approached their work differently.

PUBLIC SERVICE ACADEMY

The Public Service Academy (PSA) at Winter Springs High School inspires students to become heroes of tomorrow through careers in public service. The program provides students with an overview of the wide variety of professions in public service such as police officers, firefighters, teachers, 911 operators, and emergency managers. Students learn key employability skills such as public safety, using technology to communicate, and money management. After an initial exploration course, students choose a focused tract of criminal justice operations, emergency planning, or teaching. There are currently 259 students enrolled at the PSA.

For students to accurately train for these careers, they need relevant and up to date equipment. The Foundation partnered with corporate and government partners to provide new equipment to finish the emergency operations simulation center. The PSA was able to purchase a WeatherSTEM system to provide students with real-time and future-cast radar with a highresolution weather camera featuring a live stream. With the new system, students learn

to monitor weather safety alerts that include lightning detection and high heat monitoring, as well as tropical weather information relative to the school's location. Students are even providing relevant forecasting to the school's athletics and facilities departments to ensure the safety of students while on campus and engaging in activities.
